Rates for Services:

The majority of work is billed at an hourly rate plus expenses. My fees are adjusted periodically and we will notify you in advance, in writing, of any adjustments. You will be offered a minimum of 30 day notice of any intent to adjust fees.

In the event you require a consistent and substantial volume of work (for consulting only, not designated expert witness work), I am able to offer discounts on our fees TBD in advance. Any discounts offered are conditional upon your timely payment of its invoices and can be cancelled or adjusted if your account falls into arrears.

Costs and Expenses:

There are certain other costs and expenses in addition to the fees for legal services for which you will be charged possibly including: long distance telephone calls, government fees and related expenses, messenger costs, travel costs, transcript fees, parking charges, computerized research fees, printing and photocopying costs, sub contracted consultants or laboratory fees retained on your behalf, and other similar costs and

Expenses. My office will advance routine telephone, mail, photocopy, and courier services fees and include these on our statements to you. All other costs incurred such as associate fees, and investigation costs could be forwarded to you for direct payment to the vendor TBD in advance. We will work with your firm to minimize costly expenses whenever possible.

Considerations:

- Initial Consultation (Less than 30 minute via Telephone) No Charge.
- Hourly rates are billed in (.25) hour increments Minimum.
- Drive time and travel (flight) time billed at lowest rate per hour from home office departure to arrival, unless arranged otherwise.
- Miles driven from our office to a site, office, trial etc...and back will be added as an expense of \$.55 / Mile per incident.
- Multiple days are usually billed at between 8-12 hours per day TBA.
- Normal travel expense (Airfare, Taxi, Hotel, Meals, Car, Gas Etc...) Reimbursement is to be Paid Net 14 Days, or in advance TBA.
- Expert Witness Fees are to be paid Net 30 Days after receipt of statement, or in advance TBA.

Collections on unpaid Statements:

- In the event that we (EWS) or an agency makes reasonable attempts to collect on an open Invoice that is past due, it will be sent to a collections agency. In the event that the collection agency is not successful, we may turn it over to an attorney that could initiate a case against you and/or your firm to collect.
